If the animal is disqualified because of a positive test and/or the carcass is condemned at slaughter, any financial responsibility resulting from said condemnation will be borne by the exhibitor.

We will indemnify and hold harmless the Noble Foundation and assisting organizations, their employees and agents, against all legal and other proceedings in connection with said drug testing. We will indemnify and hold harmless the Noble Foundation and assisting organizations against all claims for injury to the animal and any damage or injury to any person or property caused by any animal.
